## Helping the Youngest Victims of Violence

Child & Family Services' Caring Network helps youth between the ages of 4-14 living in New Bedford cope with and express their feelings after having witnessed violent situations. "Many of the children live in impoverished homes or neighborhoods and have witnessed either their parents, guardians, or other adult expressing physical or verbal abuse," said Cynthia Poyant, program coordinator for the Caring Network. "In some cases, children have been abused, have witnessed murders involving gangs or drugs, are being bullied at school, or have anger issues as a result of the violence they experience at home."

In addition, there is the ever prevalent array of violent media available to kids. Video games, movies, television shows, magazines; the list goes on. Whether kids are actively seeking out violent material, or happen upon it, their curiosity often gets the better of them, leaving them disturbed and unable to process what they have experienced.

Referrals into the Caring Network are typically made by a school adjustment counselor, who provides the necessary documents to the child's parent or guardian, who then acknowledges that their child will begin receiving school-based group therapy. Weekly phone contact with the family is routinely made thereafter to follow up with each child's progress at home.

The Caring Network's group sessions are held during lunch period in a private designated room at various elementary and middle schools in New Bedford. Each group consists of 4 to 8 children, two Caring Network staff, and a school adjustment counselor. "Right now we have two part-time staff: one master's level and one English/Spanish speaking bachelor's level care manager, and are currently seeking to hire a third," said Mrs. Poyant.

Each session lasts just under 45 minutes, during which different topics are covered related to each child's traumatic experiences. Worksheets on personal and



peer safety, open group discussions, and therapeutic games are all part of the group curriculum. Relaxation sessions, drawing and coloring, in addition to modeling clay are sometimes used to provide stress-free learning experiences. "These kids haven't had the chance to just be kids," said Mrs. Poyant of the children so subject to a violent or stressful home life that have not been given the attention or affection young children deserve.

"Something we have tried incorporating lately is Model Magic," said Mrs. Poyant. "It's less messy and time consuming than clay and we use it as an opportunity for the kids to learn peer cooperation and emotional expression. Model Magic and Legos are great additions for our groups, but due to our limited budget, are currently items on our 'wish list'." In the past, the Caring Network held a drop-in art therapy group at the Dennison Memorial Community Center, and is looking to include an after school group in the future to provide longer, more in depth therapeutic sessions. ■
